

Joe Biden and Kamala Harris Success and Accomplishments

- ✓ American Rescue Plan Act of 2021—\$1.9 trillion COVID relief legislation provided direct payments of \$1,400 to Americans, \$300 per week in unemployment benefits, expanded the child tax credit and reduced ACA health care premiums helping families during COVID.
- ✓ Infrastructure Investment and Jobs Act of 2021—\$1.2 trillion bipartisan legislation providing enhancement and repairs to transportation, broadband internet, power infrastructure and clean drinking water. Provides Nevada with more than \$2.2 billion for airports, bridges, public transportation, expanded broadband, clean drinking water and electric school buses.
- ✓ Inflation Reduction Act of 2022—Legislation passed with no Republican support. Increased the corporate tax rate to a minimum of 15%; funded the IRS with \$80 billion to hire new agents and modernize their systems; reduced the cost of insulin for seniors to \$35 per month; capped prescription drugs to \$2,000 per year; gave Medicare the power to negotiate prescription drug prices; implement climate initiative to reduce greenhouse emissions; and reduce the federal deficit.
- ✓ Chips and Science Act of 2022—Bipartisan legislation providing for the manufacture of semiconductor chips in the U.S. and strengthening innovation. Reno has been designated as one of 31 tech hubs in the United States.
- ✓ Honoring our PACT Act of 2022—Bipartisan legislation significantly improves healthcare access and funding for veterans who were exposed to burn pits and toxic substances during their military service. More than 5,000 Nevada veterans have enrolled in these benefits.
- ✓ Bipartisan Safer Communities Act—Bipartisan legislation passed in 2022 helping states implement and run crisis intervention programs; barred certain individuals convicted of domestic violence from having guns; increases funding for mental health and school security and narrows the “boyfriend loophole.” First major gun safety legislation in more than 30 years.
- ✓ Overturned the Trump-era ban on openly transgender members of the U.S. military.
- ✓ Rejoined the Paris Climate Accord in a commitment to mitigate climate change.
- ✓ Supports Ukraine against the Russian invasion; doing so strengthened the NATO alliance supporting Ukraine; adding Finland and Sweden to NATO. Imposed stiff economic sanctions on Vladimir Putin for invading Ukraine.
- ✓ Highest appointment of federal judges since 1981. 181 judges have been nominated. Including one U.S. Supreme Court appointment; 40 to the U.S. Court of Appeal; 138 to the U.S. District Court; and 27 are awaiting confirmation in the Senate. (as of February 28, 2024)
- ✓ Appointed Ketanji Brown Jackson as the first black woman to the U.S. Supreme Court. She was sworn in on April 7, 2022 with a bipartisan vote of 53 to 47.
- ✓ Saving on a Valuable Education (SAVE) plan—An income-driven repayment plan based on income and family size. This plan has canceled more than \$125 billion in student loan debt to more than 3.9 million borrowers as of February 21, 2024 with more relief coming the next four years. More than 1,650 Nevadans with student loan debt have had student loan forgiveness totaling more than \$13.9 million as of February 2024.
- ✓ Avi Kwa Ame National Monument—Established in 2023 to protect almost 506,00 acres of the Mojave Desert in southern Nevada.
- ✓ Energized economy has reduced unemployment rates to historic lows.
- ✓ More than 20 million jobs have been created since January 2021.
- ✓ Supports women’s health care and access to abortion care.
- ✓ Highest stock market values in history.
- ✓ Moratorium on federal executions.
